



Party Guidance / Terms and Conditions of Use.

We would like your special day and visit to Transgression Park to go swimmingly! Please read through the following Party Guidance for the main points and our full Terms and Conditions of Use.

DEPOSITS AND PAYMENT

Please note that a **non-refundable** deposit is required to secure a party booking. Deposits are £30.00 for all party packages with the exception of 'Full Park Hire' which is £50.00.

Transgression Park has a **minimum requirement of 5 participants** per party package. You will only pay for those participants that attend on the day, subject to the set minimum of 5 participant's entry. **If you know that a child is ill or cannot attend in advance of your party and this would take you below the 5 minimum, please try to replace them.**

Your booking is confirmed for the number of users and equipment stated in your confirmation email. **Should you wish to make any amendments** to your party booking such as the number of participants or equipment required, please contact us as soon as possible before the party date.

Payment in full (less your deposit) is required on the day of your party. This can be in cash or by debit/credit card.

ENTRY REQUIREMENTS

All skatepark participants must be aged **5 years and above**.

All party participants must have a membership form/disclaimer completed by a parent/guardian or responsible adult. It is recommended that you have a form completed and brought with you on the day of the party for speed of access. Failure to bring a completed form may result in access being denied or delayed until a form is completed.

Suitable clothing and footwear should be worn including long sleeves and trousers/leggings/jeans etc. Footwear should be secure, flat and suitable for sport i.e. trainers

Customers own equipment brought to a party should be fit for skatepark use and not be a toy. Three wheeled scooters will not be permitted. Please see our full **HELMET & SAFETY EQUIPMENT POLICY** below.

ON THE PARTY DAY

All sessions and parties begin on the hour. We recommend that you and your guests arrive at least 10 to 15 minutes prior to your start time to enable us to kit your party group out in safety gear etc.

Party Food: If you have chosen to eat with us after your time in the Park we will take your order from the menu selected on arrival. Your food will then be cooked to order and ready at your reserved tables shortly after your session has ended.

We have attached the menu to your confirmation email as a reminder of what is available. **If you would like to add on any additional kids or adults to the food order please alert our staff on arrival** and they will be happy to do this. Party food packages are paid for at our main till along with the rest of the party items. **Any additional teas/coffees and snacks can be paid for in cash only at our café.**

You are welcome to bring along your own birthday cake.

Please arrive with your party guests, completed disclaimers a birthday cake if you wish and we will do the rest!

Terms and Conditions of Use:

1. You recognise the high risk of injury involved with participation in the various activities undertaken at Transgression Park. By entering Transgression Park, or consenting for a child to enter you are agreeing to participate at your own risk.
2. You agree to waive all liability claims against Transgression Edinburgh Ltd, Transgression Foundation C.I.C its subsidiaries and associated companies, its directors, employees and volunteers for any injuries, ailments or other damage to yourself whilst using Transgression Park other than due to our proven negligence.
3. By signing the disclaimer form you confirm that you have no pre-existing medical conditions that may be aggravated by participating in the activities at Transgression Park. Including but not limited to, pregnancy, high blood pressure, epilepsy, back problems, neck problems or any heart condition.

MEMBERSHIP FORMS / DISCLAIMERS

4. Transgression Park is a Members only establishment. A relevant Membership form and Disclaimer Notice must be completed before you are permitted to use the skatepark facilities.
5. Standard Membership is free of charge and continuous. Premium Membership can be purchased and entitles the bearer to discounted entry as advertised. Premium Membership must be renewed annually.
6. All members must display their Membership card to prove that a disclaimer has been completed and to gain entry.

HELMET & SAFETY EQUIPMENT POLICY

7. Transgression Edinburgh Ltd & Transgression Foundation C.I.C strongly recommends that ALL participants wear a protective safety helmet as well as kneepads, elbow pads and when applicable wrist guards. **Helmets are compulsory for those aged 15 and under. Participants aged 16 and over MAY opt out of wearing a safety helmet but accept that they do so at their own risk.**



8. **Participants aged 15 and under:** It is compulsory to wear a safety helmet at all times whilst using Transgression Park. Participants must have a disclaimer form signed by a parent, guardian or responsible adult.
9. **Participants aged 16 and over:** You may complete your own participant disclaimer. Should you wish to opt out of wearing a safety helmet you MUST sign a separate disclaimer indemnifying Transgression Edinburgh Ltd, Transgression Foundation C.I.C and its subsidiary and associated companies, its directors, employees and volunteers for any injuries, ailments or other damage to yourself whilst using Transgression Park other than due to our proven negligence.
10. All participants must wear suitable clothing and footwear.
11. Customer equipment brought to the Park must be designed and built for skatepark use and not be a toy. Customer equipment should be in good, safe working order. Transgression Edinburgh Ltd, Transgression Foundation C.I.C its subsidiaries and associated companies, its directors, employees and volunteers accept no liability for damage to or injury caused by customers own equipment.

CONDUCT AND PARK USAGE

12. You agree to conduct yourself according to the generally accepted rules of safe etiquette whilst participating in sessions within the park.
13. You should not attempt to perform manoeuvres that are beyond your skill level.
14. In the interest of safety and hygiene NO food or drink should be brought onto the Park surface. This includes bags which contain food or drink. Food and drink may be consumed in the designated café and viewing area(s).
15. No throwing of objects is permitted, including helmets, skateboards, bikes etc. at any time.
16. Children under the age of 10 must have a parent or responsible adult in the building at all times. Under no circumstances are children 10 and under to be dropped off and left unattended.
17. Smoking will not be permitted inside or at the entrance and exits of Transgression Park.
18. Abusive, discourteous or otherwise anti-social behaviour in or around Transgression Park will not be tolerated.
19. Littering, vandalism or unauthorised graffiti will not be tolerated anywhere in or around Transgression Park.
20. You agree not to use Transgression Park whilst under the influence of drugs or alcohol.
21. You agree to abide by instructions given by Transgression Park supervisors, staff and stewards at all times.
22. Payment must be made prior to participating in any session. Non-payment will be treated as theft.
23. Sessions begin on the hour and no discount will be given when joining a session already in progress.
24. No cash refunds will be made for those leaving a session prematurely.
25. Transgression Park assumes no responsibility for the damage, loss or theft of any personal belongings brought into the park. Personal items should not be left unattended anywhere in or around the park. Lockers are available to hire from reception.



26. Failure to abide by these generally accepted terms and conditions or to falsify consent information will result in a refusal of entry.
27. The management reserve the right to refuse entry at any point and to change the terms and conditions of entry.
